NOTIFICATION AND NOTICE INVITING TENDER

"Invitation of bids for grant of Mining Lease for Iron ore Mineral"

In exercise of the powers conferred under Section 10(B) of the Mines and Minerals (Development and Regulation) Act, 1957 and in accordance with the Minerals (Evidence of Mineral Contents) Rules, 2015 and the Mineral (Auction) Rules, 2015 and as amended on 30.11.2017 notified there under, and also the Supreme Court Judgments, and orders in Samaja Parivarthana Samudaya and Ors v/s. State of Karnataka and Others W.P. (C) 562 of 2009, the Government of Karnataka has identified Eight (08) Category 'C' Iron ore Mines for electronic auction for grant of Mining Lease.

Only the end-users engaged in production of sponge iron and/or pig iron and/or steel and/or pellets will be eligible to take part in the auction. Consortium of end users are not eligible to participate in the auction. The end user will also include Public Sector Undertakings. In the third stage, the State Government invites tender for 08 below listed mines.
