In the matter of RPO Compliance for FY17 by Federal Mogul Goetze (India) Limited, R.R.NO.YHT 9 Yelahanka, Bangalore,

ORDERS

Preamble:

1. The Commission, based on the information furnished by the State Load Dispatch Center, had noted that **Federal Mogul Goetze (India) Limited Yelahanka, YHT-9, Bangalore [hereinafter referred to as 'the Company']**, had not complied with Solar RPO for FY-17 to an extent of **117.58 MWh** and Non-Solar RPO to an extent of **862.24 MWh**, as mandated in the KERC (Procurement of Energy from Renewable Sources), Regulations, 2011. Thus, as per the Regulations the company had to meet Solar RPO to an extent of **129.34 MWh** (110% of shortage) and Non-Solar RPO to an extent of **948.46 MWh** (110% of shortage). Hence, the Commission issued a notice on 01.12.2017, to show cause as to why action under Section 142 of the Electricity Act, 2003, should not be initiated against the Company for failure to comply with the aforesaid Regulations.
2. Whereas, the Company had furnished its reply on 05.12.2017, stating that it has complied with both Solar and Non-Solar RPO by wheeling non-solar energy of 11450 MWh and solar energy of 4-MW. The Commission after examining the reply had noted that the Company had not furnished documentary proof for

having met the Solar RPO. Hence, one more notice was issued to the Company to **appear before the Commission on 05.07.2018** with relevant documents to substantiate the compliance of Solar RPO.

3. Whereas, the representative of the Company appeared before the Commission on 05.07.2018 and submitted documents for having complied with the RPO.
4. The documents furnished by the Company were sent to SLDC for verification on 01.08.2018 and the SLDC vide its letter dated 04.09.2018, after verification of the data, submitted a joint statement signed by the CE, SLDC and the authorized representative of the Company. As reported by the SLDC, the Company has purchased 650 MWh of wind energy in April,2017 & 610 MWh of wind energy in May,2017, aggregating to 1260 MWh, to meet the Non-solar RPO target of 862.24 MWh and 340 MWh of solar energy in April,2017 & 300 MWh of solar energy in May,2017 aggregating to 640 MWh, to meet the solar RPO target of 117.58 MWh.
5. In view of the above submissions made by SLDC, the Commission may set off 862.24 MWh against 1260 MWh Non-solar energy purchased for meeting the Non-solar RPO target and 117.58 MWh against 640 MWh solar energy purchased for meeting the solar RPO target.
6. Hence, the following orders, -


**ORDER**

1. The Commission notes that, the Company has purchased 650 MWh of wind energy in April,2017 & 610 MWh of wind energy in May,2017, aggregating to 1260 MWh, to meet the Non-solar RPO target of 862.24 MWh and 340 MWh of solar energy in April,2017 & 300 MWh of solar energy in May,2017 aggregating to 640 MWh, to meet the solar RPO target of 117.58 MWh. Hence the Commission, hereby decides to set-off 862.24 MWh (Eight hundred and sixty-two point two-four only) against 1260 MWh (one thousand two hundred and



sixty only) Non-solar energy purchased for meeting the Non-solar RPO target and 117.58 MWh (one hundred and seventeen point five-eight only) against 640 MWh (Six hundred and forty only) solar energy purchased for meeting the solar RPO target. **Therefore, the Company having fully met its Non-Solar and Solar RPO for FY17, the Commission hereby treats the proceedings initiated against the Company as closed.**
