**Draft Conditions of Supply of Electricity of Distribution Licensees in the  
State of Karnataka (CoS) (Eighth Amendment), 2018**

**Preamble:**

The Conditions of Supply of Electricity of Distribution Licensees (CoS), in the State of Karnataka, were notified by the KERC, in the Karnataka Gazette on 17<sup>th</sup> June, 2006, in exercise of the power conferred by Section 16 of the Electricity Act, 2003, (Central Act No 36 of 2003). Subsequently the said Conditions of Supply have been amended from time to time.

Whereas now, the Bangalore Electricity Supply Company Ltd (BESCOM), a Distribution Licensee, has requested the Commission to **notify appropriate provision for a dedicated and mandatory Electric Vehicle Charging Points at the parking space of the High Rise Buildings, Shopping Malls, Apartment Complex, etc.**, in pursuance of the Karnataka Electric Vehicle & Energy Storage Policy 2017 so as to support electric mobility efforts and initiative of the State Government in the larger interest of protection of environment.

Considering the above request as reasonable, the Commission, in exercise of powers, conferred by Section 16 of the Electricity Act, 2003 (Act No. 36 of 2003) and the Clause 46 of CoS, proposes to make, further amendments to the Conditions of Supply of Electricity of Distribution Licensees in the State of Karnataka as follows, namely -

**1. Title and commencement. -**

- (a) This may be called as the Conditions of Supply of Electricity of Distribution Licensees in the State of Karnataka (CoS) (Eighth Amendment), 2018.
- b) It shall come into force from the date of its publication in the Official Gazette of the Karnataka State.
- (c) It shall apply to all the Licensees engaged in the business of distribution of electricity and the consumers of electricity in the State of Karnataka.

**2. Amendment of certain clauses. -**

In the Conditions of Supply of Electricity of Distribution Licensees in the State of Karnataka, 2006, after the existing clause 9.0, the following clause shall be inserted, namely -

**"9.0 A -Applicable to Commercial / Residential Buildings (s) / Complex (es) / MS building (s)** in Metropolitan / Urban Development Authority Areas in cities having City Corporations in the State of Karnataka where:

- (a) Requisitioned load is **500 kW or more** or
- (b) Where the built-up area of the building is **more than 10,000** Square meters.

The Owner / Promoter / Occupier of the above buildings who have applied for power supply, in addition to the conditions prescribed in other clauses shall also provide not less than two number of charging points capable of charging Electric Vehicles, whether four, three or two wheeler with adequate space in such buildings.

The above amendment to the CoS has been published to invite suggestions / objections / views from the general public and interested persons, may file their suggestions / objections / views if any, on the proposed amendment in writing **before the Secretary, KERC, # 16C-1, Millers Tank Bed Area, Vasantha Nagar, Bengaluru 560 052** or through email [kerc-ka@nic.in](mailto:kerc-ka@nic.in) on or **before 24.12.2018**.
