The Appellant has filed Memo dated 03-12-2018, by inter-alia stating that there is an error occurred in the order dated 5<sup>th</sup> November 2018, passed by this Authority, and the same is required to be rectified by way of issuing corrigendum to that effect, in the interest of equity and justice.

On perusal of the documents filed by the Appellant, it is observed that an error has occurred in the Order No. **OMB/H/G-295/2018/D-1114** dated **05/11/2018**, which reads as:

**In view of the foregoing facts, the appeal is allowed and directed the Respondent No.1 AEE to:**

- 1) **Pay interest to the appellant as per SBI base rate 9.1% per annum as per Clause 3.1 of KERC (Interest on Security Deposit) Regulations 2005 excluding 6 months from the date of disconnection i.e., from February 2006 to November 2009.**

- 2) **Pay interest amount at the rate of 2% per month as per clause 29.08 of Conditions of Supply of Electricity of Distribution Licensees in the State of Karnataka for the delayed period in crediting the refund deposit amount to the appellant's account i.e., Jan 2010 to Oct 2017.**

The above order may be read as:

### **CORRIGENDUM ORDER**

**In view of the foregoing facts, the appeal is allowed and directed the Respondent No.1 AEE to:**

- 1) **Pay interest to the appellant as per SBI base rate 9.1% per annum on collection of fixed charges as per Section 62(6) of Electricity Act, excluding 6 months from the date of disconnection i.e., from February 2006 to November 2009.**
- 2) **Pay interest amount at the rate of 2% per month as per clause 29.08 of Conditions of Supply of Electricity of Distribution Licensees in the State of Karnataka for the delayed period in crediting the Monthly Minimum Charges, (Fixed Charges & Tax) amount to the appellant's account i.e., January 2010 to October 2017.**

This order shall be implemented within Thirty days from the date of issue of order, and compliance be reported.
