**APPOINTMENT OF CHAIRPERSON OF THE  
KARNATAKA ELECTRICITY REGULATORY COMMISSION**

1. (a) The **Karnataka Electricity Regulatory Commission (KERC)**, an independent Regulatory body consists of a Chairman and two Members. As the vacancy of Chairperson, KERC, would arise on 15.12.2009, a Selection Committee has been constituted to select and recommend the panel of names to the Government.  
  
(b) Applications from suitable persons are invited for selection as Chairperson of the Karnataka Electricity Regulatory Commission.

2. **ELIGIBILITY**

The Applicant shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to **engineering, finance, commerce, economics, law or management**.

3. **AGE**

The maximum age limit for appointment of Chairperson, KERC is 62 years on 15.12.2009.

4. **TENURE**

5 years or on attaining 65 years of age, whichever is earlier.

5. **REMUNERATION**

As per the KERC (Chairman and other Members' Remuneration / Allowance and Conditions of Service), Rules, 2000 as amended from time to time.

6. **LAST DATE FOR RECEIPT OF APPLICATION**

On or before 7<sup>th</sup> December 2009 up to 5.30 PM.

7. Application in the following prescribed form-1 duly signed by the Applicant **shall be sent by Registered Post** to reach the above mentioned address, on or before **7<sup>th</sup> December, 2009 5.30 PM**. Applications received after 07.12.2009, 5.30 PM will not be considered.

The Applicant shall also furnish the details of any office, employment or consultancy agreement or arrangement which he has in his own name or in any firm, association of persons or body corporate or in the names of any relative, carrying on any of the following business or any financial interest therein.
  - (i) generation, transmission, distribution or supply of electricity;
  - (ii) manufacture, sale or supply of any fuel for generation of electricity;
  - (iii) manufacture, sale, lease, hire, supply or otherwise dealing in machinery, plant, equipment, apparatus or fitting for the generation , transmission, distribution, supply or use of electricity, and
  - (iv) any entity providing professional services to any of the business referred to in (i), (ii) and (iii) above.
9. Applicant should not have any financial or other interest which is likely to affect prejudicially his/her function as Chairperson, KERC. A declaration on this be furnished.
