**Amendment to KERC (Duty of the Licensee to supply Electricity on request)
Regulations, 2004**

Preamble:

In exercise of the powers conferred by clause (t) of sub-section (2) of section 181 read with sub-section (1) of section 43 of the Electricity Act 2003 (Central Act 36 of 2003) and all powers enabling it in that behalf, the Karnataka Electricity Regulatory Commission had notified, "KERC (Duty of the Licensee to supply Electricity on request) Regulations, 2004" in the Notification No. F/ D / 07 / 5 dated.28.9.2004 and the same was published in Part-3 (Page nos.1867 to 1869) of Gazette of Karnataka dated 21.10.2004.

With the said issuance KERC (Duty of the Licensee to supply Electricity on request) Regulations 2004, certain provisions made under K.E.R.C. (Electricity Supply & Distribution) Code 2000-01 noted below have become redundant.

- a) 4.01 (ii)
- b) 4.02 (a) and (b)
- c) 4.05 (iv) to (Vii)
- d) 4.11 (i)
- e) 5.01 (d) and (f)

AMENDMENT

In exercise of the powers conferred by clause (t) of sub-section (2) of section 181 read with sub-section (1) of section 43 of the Electricity Act 2003 (Central Act 36 of 2003) and all powers enabling it in that behalf, the Karnataka Electricity Regulatory Commission hereby makes the following Regulations further to amend KERC (Duty of the Licensee to supply Electricity on request) Regulations, 2004.

I. Title and commencement:

- a) These Regulations may be called the KERC (Duty of the Licensee to supply Electricity on request) (Amendment) Regulations, 2005.
- b) These Regulations shall come into force from the date of publication in the official gazette of Karnataka and will be in force unless amended otherwise.
- c) These Regulations shall extend to the whole of the state of Karnataka

II. Amendment in the KERC (Duty of the Licensee to supply Electricity on request) Regulations, 2004. The existing Sections as in column 3 of the Table below shall stand substituted by the provisions as in column 4.
